A WORD FROM OUR FOUNDER AND CEO Thea Ramirez

Archimedes once said, "Give me a lever long enough . . . and single-handed I can move the world." Arguably the fulcrum underpinning every success is the utilization of the right leverage. When attempting to solve complex social problems, often we believe that the right solutions lie somewhere beyond our ability to access them. As a result, we get stuck in a cycle of wishful thinking, all the while failing to closely examine the tools we have right at our fingertips.

Today, an unprecedented amount of knowledge and innovation is available to build solutions for child welfare and children in foster care. Chief among these revolutionary tools and seemingly most ignored in the child welfare arena is the utilization of data and predictive analytics in the process of decision making. Big data interfaces with every sector of society; its algorithms able to inform, educate, and predict connections between both related and seemingly unrelated things. Yet, our utilization of data to help children and families is underwhelming, an ignored fulcrum that could empower us with unprecedented leverage.

When leveraged appropriately, data not only has the power to inform the future but it also has the power to make sense of our past. For years, the issues that pervade the child welfare system in the United States have been misdiagnosed as a lack of resources or families needed to ensure every child with a goal of adoption gets adopted.

As a result, our full-court press has been on recruitment of new families by marketing the faces of vulnerable children. Without a systemic understanding of our problem, these solutions inadvertently create today's bottlenecks which cause both families and children to wait. I propose that technology and data are the right fulcrums we have been missing to solve what is fundamentally a *connection* problem.

For the past decade despite a plethora of nationwide strategies and sophisticated campaigns, data from AFCARS reveals our country's adoption success rate for foster youth has hovered around 50%. This means that we are in essence failing at moving children into permanency through adoption, regardless of how many children entered or exited care in a given year. All the while children wait to be adopted. Families who have been recruited, trained, and licensed also wait to adopt these very same children. Nothing quite drives this point home for our team more poignantly than a family who felt a call to adopt children from foster care. After inquiring on over 180 kids marketed for adoption across the country, 18 months in and zero responses later, they came close to giving up. They wondered why this was so difficult when the need for homes was so great. When this same family began to use our Family-Match tool, the results were truly disruptive.

After creating a profile on Family-Match, they were matched with a sibling set of 4 from the opposite corner of their state in just 2 business days. This family that had been waiting for 18 months and had almost quit the process, had finally leveraged the right fulcrum.

Technology can help solve the connection problem and release the bottlenecks that prevent children in foster care with a goal of adoption from being adopted. Adoption-Share's Family-Match Program is solving the connection issue in the United States by leveraging data and predictive analytics to efficiently and appropriately connect waiting children and waiting families.

The heartbeat of Adoption-Share is and has always been families. Our greatest solution to permanency for children in foster care are stable families, and our Family-Match application is uniquely postured to improve the system by making advances in the compatibility of matches, building efficiency for state agencies and affording children a place to belong.

Let's commit to working smarter. Let's commit to investing wiser. Let's commit to bringing our best to solvable problems and leverage solutions that are already right at our fingertips.

Adoption is Beautiful is a national movement that exists to ignite a postive and informative conversation about adoption in the United States. Through our online plaform, we have reached millions of people through strategic campaigns with organziations that include the New York Stock Exchange, Miss USA, Warner Brothers, and Paramount Studios.

"I have wondered how my life might have been different had I been raised by my birth mother...

There was a reason she placed me for adoption as an infant. I was raised by a loving mother and father who adopted two more children who became my brother and sister. We were a pretty normal, middle class family. Then, at the age of 16, I became pregnant and placed my baby boy for adoption.

When the child was born, the mothering instincts kicked in and there was a fleeting thought of changing my mind as I held and rocked that tiny life in the hospital. But the ordeal forced me to be exceedingly "real" with myself and just like my biological Mom, I wanted my baby to have better than what I knew I was capable of at the time. The adoption agency said I could write a letter to my son that the couple could give to him when he was old enough. So I did. Then, through the agency, I received a photo of the baby from the couple. And that was it. I recovered and went on with my life—but from time to time would wonder about him. I never ended up being married nor had any other children.

Just a few years ago, I received a phone call from a search agency. Now an adult of 30, he wanted to contact me to let me know how things had turned out for him. He still had the letter I had written long ago. We exchanged e-mails and phone calls. His family invited me down to South Carolina for his college graduation and Christmas vacation. His family extended their love and embraced me as a part of their family. Sadly, his mother had just passed away from cancer.

The big surprise was that she was the nurse in the delivery room when he was born! She and her husband had been trying to adopt for 7 years and when she learned he was available for adoption, she spoke up for him. God is at work behind the scenes and has a way of turning very difficult circumstances into something beautiful.





"I am a nurse and was working at a hospital when...

A coworker of mine was telling me about her daughter who was pregnant. She said her daughter is going to choose adoption. Right then and there I started to shake, my heart was pounding and I said "that's my son!" She looked at me and said "yes I think it is!" She didn't even know my heart, my desires for another child. But God knew. He wrote this story and was about to bring it to life.

On July 29th 2013 my son was born via c-section from the most beautiful woman. When I saw him take his first breath mine was taken away. I cried the ugliest cry of my life. It was unbelievable. Our son Jackson Carter May has taught me forgiveness, grace, mercy and that God is ALWAYS there. Even when you don't feel him, or know Him.

FAMILY-MATCH | VIRGINIA Bringing Reform

Our theme in Virginia continues to focus on leveraging Family-Match to promote necessary reform required for children to achieve permanency through adoption. Our focus adjusts this work from an attitude of, "just keep pushing," to a posture of willful curiosity that helps our team gain understanding of the barriers that keep workers from matching waiting children with waiting families.

We tripled participation from public and private agencies to 114 by December of 2019. In addition to tripling agency participation, we have also enjoyed building relationships across the state legislature and leadership.

We are grateful to all of our family ambassadors, local and private agency partners, and State Senators Barbara Favola and Janet Howell, as well as former State Senator Glen Sturtevant. These relationships have allowed us to target our curiosity in meaningful ways, birthing new dialogues statewide and delivering on new results.

This pivot in how we engage the state allowed our team to make significant progress in advancing the more important conversation of needed change and transformation. made, our team measures the quality of the matches through a series of post placement assessments. The outcomes obtained inform future iterations of our matching model.

Here's how Family-Match is engaging these three states:



Though these needs are often outside the scope of Family-Match, our team consistently worked with the Commonwealth of Virginia Department of Social Services to ignite the sparks of evolution on the individual, regional, and systemic levels of the state.

The following are a few examples of the immense progress that was achieved this year.

Progress	Pain Point	Solution
Sharing of Home Studies	Accessing home studies is one of the most narrated pain points experienced by families in Virginia. Families get approved and achieve a completed home study, however, the vast majority of families are left without custody of the finalized report. This process ultimately leaves many families unable to actively engage to find their match.	Family-Match designed a home study upload tool, crafting a path for a worker to upload a report on behalf of a family while also meeting caseworker requirements that families not have direct access to the report.

Family Prescreening	Thousands of eager, interested foster and adoptive families respond to recruitment campaigns without an understanding of what is required and where help is most urgently needed. As a result, inquiries fom interested families overwhelm the child placement agencies, slowing down the act of linking the right people to the right agency in an efficient and fluid process.	Family-Match created Faster Families, a web based application to equip family recruitment organizations with ways to better educate families about the needs in their own community and shift efforts to identify and expedite families that match those goals. Workers can better target their recruitment efforts to those families most able to meet needs.
	Results: Launched a beta pilot in the fall of 2019 and initial feedback from case workers has been tremendously positive! Family-Match also secured a role on the VDSS' state-level recruitment and retention working group, a position typically closed to those outside of VDSS leadership.	
Sharing Licensed Families	Family-Match acts as a central repository for licensed and waiting adoptive parents, who largely remain unmatched due to counties unable to work with each other to support out of county adoption matches.	Working with VDSS, Family-Match prioritized efforts in 2019 to the sending county and receiving county and to promote a more robust conversation supporting guidance to county offices on how to work with each other to promote the adoption of waiting children.
	Results: Through a series of regional conversations and a VDSS authorized survey, our team identified two significant barriers that impede inter-county adoption matching. Lack of financial resources/incentives to justify the expense of inter-county adoption and insufficient guidance to inform best practices.

FAMILY-MATCH | FLORIDA Bringing Efficiency

2019 has been a year of continued growth and success in Florida. Family-Match is now utilized by adoption providers and lead agencies in every area of the state. Since implementation, over 1100 families have created profiles in Family-Match, and over 1200 cases have been entered in the system.

These efforts have resulted in a 175% increase in children being matched and placed – and 97 FINALIZED ADOPTIONS!

In partnership with the Selfless Love Foundation, Adoption-Share is focused on assisting agencies with fully integrating Family-Match in their systems, developing and refining functionality to increase efficiency and efficacy, and streamlining the recruitment pipeline for both workers and waiting families.

Having worked in child welfare systems for many years, I am thrilled to be part of the Adoption-Share team. It is truly an honor to assist workers and families in creating forever homes for children.

Adoption-Share's intuitive Family-Match Program matches children with compatible families

Through Adoption-Share's proprietary matching system, Family-Match generates connection the moment new candidates are identified and allows caseworkers the opportunity to connect with families directly.

FAMILY-MATCH | TENNESSEE Bringing Innovation

Working with Tennessee's Department of Children's Services (DCS), we developed training content and completed the first ever integration with a state's child welfare system. In recognition of our work with DCS over the past 3 years, the state awarded Adoption-Share a \$50,000 grant to help compensate time and costs invested in this complex project. We are happy to report that not only did DCS and Adoption-Share complete the integration build out for Tennessee's benefit but also ensured our methodology and approach could be extended to our work in future states in which there is interest in applying Family-Match's compatibility system to help a child's first placement in foster care be their only placement while in care.

Adoption-Share recognizes the negative impact that can result for children who move from home to home during their stay in foster care. We believe our matching system, designed to help children achieve permanency through adoption, can also benefit children who are entering into care for the first time. Family-Match for children in temporary foster care makes the most sense as an integrated system in which workers can examine a child and family pairing's compatibility score as a component to determining a placement decision without logging into Family-Match as a stand alone application.

Our work in 2019, also involved getting approval from the Tennessee's newly elected Governor and getting

acquainted with the newly appointed Commissioner of DCS. As we look to 2020, we are hopeful for the final green light from the new leadership to go live and help foster children in Tennessee experience stability as they move into the foster care system.

DID YOU KNOW?

Each month we offer Family-Match Family Meetings for our waiting families. Our team selects an expert to speak with families on topics that include but are not limited to: promoting healthy sleep routines for children, trauma informed parenting, toolkits to advocate for children with special needs, working through certain behaviors, and navigating through the holiday seasons. These one hour calls are designed to engage families in constructive dialogue and learning so they can be more equipped to serve their children.

K Faster Families A New Front End Tool to Our Family-Match Program

Each year thousands of people respond to awareness campaigns, marketing efforts, and faith based initiatives that seek to recruit prospective adoptive families.

Unfortunately, out of the large volume of interested families, only a small percentage will become licensed to adopt. As a result, the horde of interested volunteers overwhelms licensed child placement agencies, creating bottlenecks that slow down the process of getting the right people linked up to the right agency in an efficient and fluid process.

To address this problem and to build momentum of our Family-Match Program, our team worked with child placement agencies to design Faster Families- a system designed to stand in the gap between recruitment campaigns and organizations to better qualify leads for child placement agencies to quickly and efficiently identify the families that will be most likely to become licensed and are compatible matches with the waiting children in their agency.

We are currently beta testing our first version and thanks to support from Alithya will be unveiling our 2.0 version.

DID YOU KNOW?

Our Family-Match Program does not stop once the match has been made! We follow our matches from match to placement (when the child moves into the home full time) and from placement to finalized adoption. Our post placement assessments capture key data aimed at measuring the quality of the match so that our algorithm can continue to improve overtime.
